3. Consent Agenda

4. **Report from the President.** President Ray Allshouse announced the legislative request to Governor Inslee to delay the International Energy Code, International Mechanical Code and International Plumbing Code to July 1, 2021 was denied by Governor Inslee.

5. **Business/Action Items**

1. **SBCC Issues**

a. **Formal Request to Move Code Adoption Date to November 1 for Future Code Cycles** – Lee Kranz led the discussion on the pro's and con's of extending the future code implementation date from July 1 to November 1.

MOTION: It was moved and seconded to request the code implementation date of July 1 be moved to November 1 to ensure accuracy in the insertion process of the WAC's to the model codes and WA State insert pages.

Motion was tabled to decide timing later. Motion to table passed unanimously.

b. **WABO's Position on the 2018 Codes Being Delayed until July 1, 2021** – A discussion was held regarding two letters the SBCC received to further delay the 2018 code adoption date to July 1, 2021.

MOTION: It was moved and seconded that WABO will try to table/postpone the issue until the September 11, 2020 meeting, if unsuccessful in tabling WABO will not support the extension request. Motion passed unanimously.

c. **SBCC Process for Keeping Codes Amendments Consistent** – A discussion was held on the SBCC review process with CR102's, insert pages and ICC submittal documents.

d. **Other Issues** – None.
